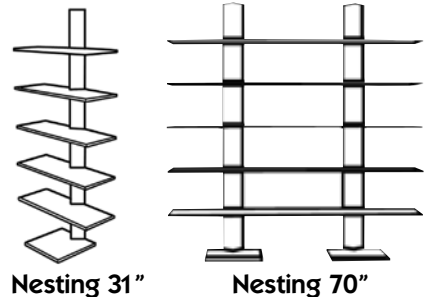

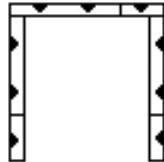

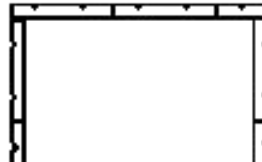

10 x 10 BOOTH



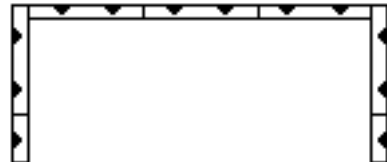
3 (31") Units plus 3 (70") Units
